Joe Willy Dunn - Director



#### Chaplain's Corner

The slogan "Once a Marine, always a Marine!" is credited to MSgt Paul Woyshner in 1917. However, it was in use for some years prior and it first appeared in print in the Galveston (TX) Daily News (Pg. 23, Col. 7) on April 14 th , 1907. Although its origin is lost in antiquity, this slogan remains in use today. The meaning is simply this: I am no longer in the Marine Corps but the Marine Corps is still in me. Regardless of their branch of service, this statement is true for most military veterans. For, when we raise our hands and take the oath, we are in military service and, by the time we complete our tour of duty, our branch of service is ingrained in us and we are a Marine, Sailor, Soldier, or Airman for the rest of our lives. How that experience affects us is subject to what we believe about our experiences, about ourselves, and about God.

Passages referring to and similar to, being in Christ, or Christ being in us, appear 242 times in the epistles of Paul and John. Galatians 2:20 (NKJV) "I have been crucified with Christ; and it is no longer I who live, but Christ lives in me; and the life which I now live in the flesh I live by faith in [of, from] the Son of God, who loved me and gave Himself up for me" is a passage which embodies both concepts. "I have been crucified with Christ..." tells us that we were placed in Christ at the cross, where we died with Him. "...and it is no longer I who live..." tells us that we are in Christ at the resurrection where we are raised with Him. "...but Christ lives in me..." tells us that the new life we received, at the resurrection, is His life. When we are discharged, we are no longer in the military. However, Ephesians 1:4 (NKJV) "...He chose us in Him before the foundation of the world, that we would be holy and blameless before Him..." tells us, the Father chose us in Christ. This is an act of God's grace and no one can undo what God has done. Therefore, we can never be "discharged" from being in Christ. Finally, Hebrews 13:5 (NKJV) "...He Himself has said, "I will never desert you, nor will I ever forsake you..." assures us that Christ was the first to promise to...leave no man behind.
