Chaplain's Corner

(excerpted from W is for Warrior)

A Veterans Court is charged with trying cases of minor offenses that involve veterans diagnosed with service-related illnesses. The first veterans' court was established in 2008 in Buffalo, NY and was used as a model for other veterans' courts in other parts of the United States. On April 20, 2016, journalist Bill Kirby, Jr. wrote an article, in the *Fayetteville Observer*, about one such Veterans Court. Much of the following is from that article.

On April 12th, 2016, retired Special Forces First Sergeant Joseph Serna was trembling with fear as he entered the Cumberland County, NC courtroom of Judge Lou Olivera. After several tours in Afghanistan, during which Serna had received three Purple Hearts, he had developed severe PTSD and was trying to cope by self-medicating with alcohol. He had previously stood before Judge Olivera 25 times as part of the Veterans Treatment Court program. His mentor was standing with him when he confessed that he had lied to the judge about the positive results of his latest urinalysis test. At that point, Judge Olivera had no choice, and he sentenced Serna to 24 hours in jail. But Olivera knew Serna could not handle a night in jail and so he did far more than just throw Serna in jail. Olivera drove Serna to the jail. The cell door closed, and Serna sat on the cot alone in the cell. Then he was shocked when the door opened, and Judge Olivera walked into the cell. Judge Lou Olivera, himself a Gulf War veteran, stayed the night in jail with the man he had sentenced, and the two men spent most of the night as two vets talking about their military service. Olivera later said, "I thought about a story that I once read. It talked about a soldier with PTSD in a hole. A family member, a therapist and a friend all throw down a rope to help the suffering veteran. Finally, a fellow veteran climbs into the hole with him. The soldier suffering from PTSD asks, 'Why are you down here?' The fellow veteran replies, 'I'm here to climb out with you.'

Judge Olivera met the requirement of the law for justice, and he also met the need for mercy. Jesus came to earth to spend time in prison with us and for us. He climbed down into a dark hole with us and for us. He suffered and was tempted in every way as we are and He met every requirement of the law including the requirement for justice and, in Him, we meet every requirement of the law for we died with Him. In Him we also received new life: His life and, in *Deuteronomy 31:8* and in *Hebrews 13: 3-5*, He promised He would never leave us nor forsake us.
